Unknown author. In the case of a work where the identity of the author is unknown, copyright in the work exists for whichever is the earlier of: the remainder of the calendar year of the first ...

For this exception to operate the work must have already been made available to the public, and the authorship of the work must also be sufficiently acknowledged.
